Representatives from the U.S. Virgin Islands engaged with African-American business leaders at the 2013 Annual Black Enterprise/Pepsi Golf and Tennis Challenge from August 29-September 1 to promote opportunities for business investment and leisure activities in the U.S. Virgin Islands. This annual event attracted nearly 1,000 African-American business executives, celebrities, and athletes to the PGA National Resort and Spa in Palm Beach Gardens, Florida.

The U.S. Virgin Islands became a sponsorship partner of this annual event in 2009. During the three-day event, USVI Governor John P. de Jongh, Jr. and VIEDA's Chief Executive Officer Percival E.
