### What is Safety in Paradise? OSHA On-Site Consultation Program

Regulated through OSHA 21(d) Consultation Program, SIP works with small, high-hazard employers to address the employer's *overall safety* and *health management system* and to assist them in ensuring a safe and healthful workplace for their employees.

> 100% federally funded by OSHA

- SIP is a free confidential service
- Independent of federal or local OSHA enforcement
- Professional consultants receive exact training as OSHA enforcement inspectors







## Who is eligible?

Private sector employers

Focus small employers (500 or less employees) in high hazard industries

Any employer who wants to achieve a safe and healthy workplace for their employees

Some include:

- Construction
- Hotel and Tourism
- Medical and Dental offices
- Retail establishments
- Telecommunications
- Banking and Insurance
- Nursing Homes





## **Benefits to Small Businesses**

Provide professional safety and health services at no cost

Help employers reduce their cost by reducing workplace accidents and illnesses

May help reduce costs due to lost productivity, training replacement workers, and compensation insurance fees
